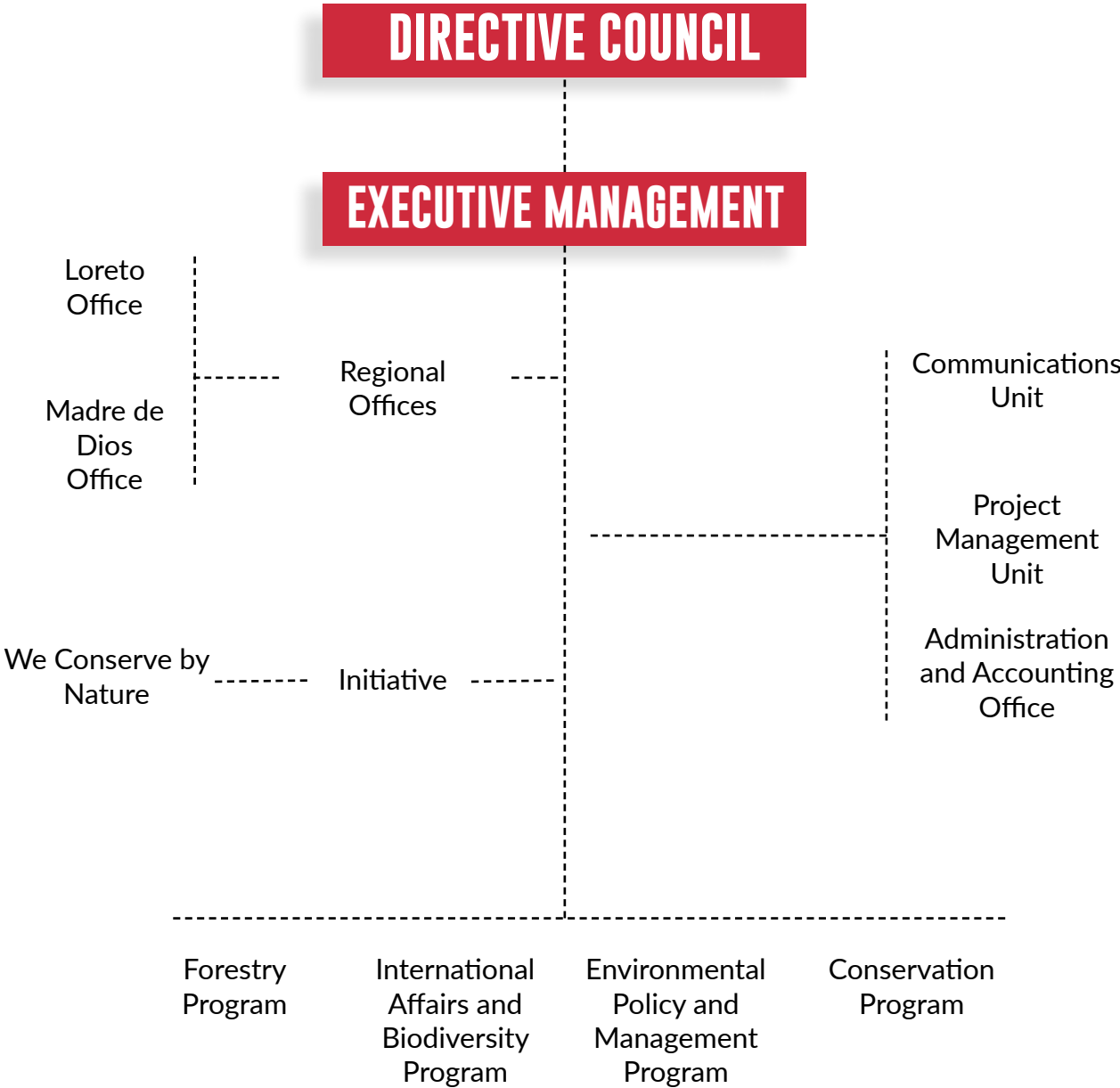

## 3 STRATEGIC LINES

### NATURAL PATRIMONY

Nature is generous and everything it offers, if managed with good judgement, will transcend to future generations. In SPDA we believe that this is the connecting thread to our development, pride and identity. This strategic line emphasizes natural protected areas (NPAs), forests, landscapes, biological diversity, agrobiodiversity, oceans, ecosystem services, regional conservation systems, water, territory and environmental compensation schemes.

### ENVIRONMENTAL JUSTICE

Empowering citizens regarding their environmental rights and strengthening institutions is much more than disseminating, understanding and implementing environmental norms. It involves exercising environmental rights in an informed and effective manner. This strategic line involves the development of case studies or research documents on emblematic issues (including illegal mining, infrastructure or plantations); free legal clinics; participative monitoring and early alert systems; transparency in information; observatories; administrative and legal cases; communication strategies and participation in civil society groups; the Program of Second Specialty in Environmental Law and the Environmental Law Workshop for Undergraduate Students.

### INSTITUTIONALITY AND ENVIRONMENTAL LEGISLATION

It is essential to have institutions with capacities in environmental issues and a coherent and systematic environmental legislation framework, as the best guarantee to translate norms into sustainable territorial management and induce concrete opportunities for development.

This strategic line is focused on the analysis and development of proposals of environmental legislation; strengthening the capacity of government institutions at the national, regional and local levels; generating civil society networks; strengthening indigenous groups through legal and technical advice; educational programs and research, among others.



# 30 YEARS

In 1986 a group of Law students decided to create the Peruvian Society for Environmental Law. Their interest: to promote Environment Law in Peru. Since then, the energy has not stopped. We are aware of the huge challenges ahead and continue to work to pursue a more equitable, sustainable and happy society, with the same joy, curiosity and commitment we started with 30 years ago.

We celebrated our anniversary by conducting a series of meetings on key environmental issues related to the development of Peru: We summarize below a year of important advances and accomplishments.

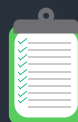

## 5 OUR WORK

2016 was an intense year, with multiple activities at various levels. We would like to highlight some of them focused on five issues:

- 1) Strengthening environmental management
- 2) The future of natural protected areas
- 3) Indigenous peoples, management and conservation
- 4) Improved management of forests, wildlife and the oceans
- 5) Protection and defense of environmental rights

## STRENGTHENING ENVIRONMENTAL MANAGEMENT

In 2016, SPDA worked in the design of new environmental management instruments and in the legal analysis of environmental assessment and enforcement systems. The purpose is to ensure compliance with environmental standards.

### ENVIRONMENTAL IMPACT ASSESSMENT

SPDA continued working to strengthen the National System of Environmental Impact Assessment (SEIA). In this regard, we analyzed the regulatory framework and identified the main challenges in environmental impact assessment processes.

In addition, we also generated proposals for the Global Environmental Certification project, to adequately organize processes and the actions of authorities, to improve the quality of information and final decision of the National Service of Environmental Certification for Sustainable Investments (SENACE).

SPDA presented a proposal to structure and implement a fund to finance technical assistance for communities, to exercise citizen participation during environmental impact assessment processes in mining activities. This tool will help to improve transparency and participation by the community, and thereby reduce socio-environmental conflicts.

## ENVIRONMENTAL ENFORCEMENT

SPDA maintained an active role, generating information on a number of issues such as oil spills, the derogation of Law 30230, Article 19 -that weakens environmental enforcement-, and different legislative proposals of SENACE and the Agency for Environmental Assessment and Enforcement (OEFA).

## ENVIRONMENTAL COMPENSATION

During the International Union for Conservation of Nature (IUCN) World Congress, we organized a discussion table to exchange views on the efforts being made in countries, to generate information tools and promote environmental and biodiversity compensation schemes.

## STRENGTHENING THE REGIONS

At the regional level, SPDA promotes knowledge and discussion spaces, and provides support to strengthen environmental institutions. In 2016, we provided training in Madre de Dios to representatives of regional governments, the academic community, civil society, among others, to strengthen their capacities on environmental matters. We also contributed in the elaboration of key management and internal organizational instruments of the Regional Environmental Authority, the new environmental authority of the Regional Government of Loreto.

## ELECTORAL ENVIRONMENTAL AGENDA CONTRIBUTIONS TO THE DEBATE

The electoral campaign and elections of new authorities in 2016 presented a great opportunity to promote the debate of ideas of environmental policies in Peru. A survey undertaken by IPSOS in February 2016, revealed that only 13% of respondents consider the environment a priority issue on the electoral agenda. Considering this result, SPDA sought to contribute to elevate the environmental dimension throughout the national political campaign.

SPDA reviewed government plans by candidates to the Presidency and evaluated their environmental component. Additionally, we promoted a dialogue with political parties through interviews with their environmental experts. We also participated in different forums such as

Sustainability: Environment and Climate Change, organized by Grupo La República y Latina; How to face climate change in Perú?, organized by The Driving Group Against Climate Change in Peru (Grupo Impulsor) of which SPDA forms a part; and the Forum on Forestry Management.

This work was accompanied by an important component of dissemination through the media and social networks.

## THE FUTURE OF NATURAL PROTECTED AREAS

During 2016, we provided technical assistance to the National Service of Natural Protected Areas by the State (SERNANP) in the design and implementation of a Sustainable Funding Strategy, an essential step for the management and the future of Natural Protected Areas (NPAs). In addition, innovative initiatives were presented such as the proposal to articulate a network of natural monuments in Peru. There are still a number of challenges for these emblematic areas of our biodiversity and natural heritage; one of these is the advancement of illegal mining.

### FINANCIAL SUSTAINABILITY FOR CONSERVATION

As part of the financial sustainability initiative for NPAs “Peru’s Natural Patrimony”, we participated in the implementation of the first Funding Plan for Natural Protected Areas by the State (SINANPE). This document was approved through Ministerial Resolution 200-2016-MINAM. As part of this Plan, more than twenty funding mechanisms were identified, four of which have been prioritized by SERNANP.

### NETWORK OF NATURAL MONUMENTS

The results from a feasibility study for the implementation of a network of natural monuments in Peru were presented to SERNANP. This network will allow the articulation, development and recognition of icons of the environment, which have been historically essential for Peruvians, such as millenary trees, caves, waves, waterfalls, stone forests and mountains, among others.

### MANAGEMENT COMMITTEES FOR NATURAL PROTECTED AREAS

Management committees are voluntary citizen participation spaces of significant importance for the management of natural protected areas. SPDA implemented tools to support the people and institutions that volunteer in monitoring, protecting, conserving and promoting environmental education actions, among other activities related to NPAs.

In this area, we contributed to the establishment of a Trust Fund for the Tambopata National Reserve Management Committee, the first trust formed to channel funds to finance activities in this reserve. Additionally, we elaborated a number of studies on the situation of the most representative SINANPE management committees, in terms of the threats they face, opportunities, strengths, weaknesses, and organizational, technical and financial needs.

## ILLEGAL MINING IN NATURAL PROTECTED AREAS

Natural Protected Areas (NPAs) constitute one of the great pillars of our national pride. However, in spite of their importance, they are being constantly threatened by the development of illegal activities such as illegal mining.

As a result, we have been working for several years on communication strategies, analysis and proposals to strengthen the fight against illegal mining, as a State policy, generating a social consensus regarding this problem. 2016 was not the exception. The main activities developed were the following:

- The design of a draft legal tool to facilitate the control, monitoring and sanctions for illegal mining in NPAs.
- The implementation of programs and modules in coordination with the Ecological Police, Environmental Prosecutors and Public Attorneys, among others, to strengthen the capacities of SERNANP members, NPA leaders and Management Committees, to deal with illegal mining.
- SPDA launched a communications campaign “Somos Tambopata” aimed towards protecting the Tambopata National Reserve from illegal mining. As part of this campaign, renowned local artists gathered to generate a call to action through the theme and video clip “El Futuro es Verde”.
- Likewise, we presented a journalistic investigation on the impact of illegal mining in five NPAs where this activity takes.

## WE CONSERVE BY NATURE (CxN)

2016 has been a year of great results and advances for We Conserve by Nature, an SPDA initiative that focuses on voluntary conservation and citizen activism in favor of nature conservation.

### DO IT FOR YOUR WAVE

This crowdfunding platform, one of the first in Peru, succeeded in raising two hundred thousand soles on the part of companies and citizens interested in the protection of waves in Peru. The campaign has managed to articulate various actors such as the Peruvian Navy, the National Surfboard Federation and SPDA, together with athletes, citizens, businessmen, institutions and local governments interested in the conservation of our sea.

### THE NATURAL ROUTE

We published the first guide on travelling to private conservation areas (PCAs) in Peru: "La Ruta Natural: Viajes y Destinos Conservamos por Naturaleza" and a new section "Explora" at [www.conservamospornaturaleza.org](http://www.conservamospornaturaleza.org) that includes key information for those interested in contact with nature.

Additionally, we implemented a Strategic Plan for tourism in the Amazon PCAs, providing sustainable funding for voluntary conservation.

## DO IT FOR YOUR BEACH

In its fourth edition and during a weekend in March, the campaign Do it for your Beach convened more than two thousand volunteers, who cleaned up our beaches to raise awareness for vacationers on plastic pollution in our seas and rivers. Cleanup campaigns in eight countries at a global level were implemented this year.

## WE REFOREST BY NATURE

This campaign which encourages the adoption of trees to promote private conservation initiatives, continues to expand. With funds raised, three projects were successfully executed in the PCAs Milpuj - La Heredad and Bosque Berlín and Asociación Bosques del Futuro Ojos de Agua, focused on improving tourist attractions and lodges in the areas, reforestation and production centers of eco-products. Funds raised in 2016 were invested in these three areas in addition to PCA Paraíso Natural Iwirati.

## SCHOLARSHIPS CONSERVE PERU

Twelve students and young professionals elaborated projects in support of voluntary conservation areas for a value equal to fifteen thousand soles. The scholarship awardees conducted several activities according to the needs of each area, such as preparing files to create new private conservation areas in Loreto, coordinating the campaign Remando Jutos por el Mara  n, or the planting and coding of trees for the campaign We Reforest by Nature.

## NETWORK OF VOLUNTARY CONSERVATION INITIATIVES IN THE AMAZON

In 2016 we were able to expand our support of the Network of Voluntary Conservation Initiatives in the Amazon by hiring a coordinator to assist in project planning, legal matters and the purchase of equipment.

## PRODUCTS FROM CONSERVATION AREAS

2016 was a very positive year regarding the promotion of products from private conservation areas. Through our alliance with a social enterprise Shiwi and the diversification of sales points, from 2015 to 2016 it was possible to increase sales from fifteen thousand to more than ninety thousand Soles. Profits above fifty one thousand Soles were generated for PCAs.

## CARNET CXN

Through alliances with forty-five companies, we introduced the new I.D. Card We Conserve by Nature. This card is an incentive for those who want to support voluntary conservation initiatives and provides discounts and benefits. The card costs twenty Soles, and funds are assigned to CxN projects.





## INDIGENOUS PEOPLES, MANAGEMENT AND CONSERVATION

The management of land and social conflicts, as well as the recognition of ancestral knowledge, are undoubtedly essential aspects towards the strengthening of Indigenous Peoples rights. In 2016, we analyzed issues related to the review of the physical-legal status of indigenous territories; we worked at the local and regional levels in the design and implementation of a strategy to manage and transform socio-environmental conflicts, and contributed to research and the legal framework related to agrobiodiversity and ancestral knowledge.

### LAND MANAGEMENT

SPDA contributed to the physical-legal review of indigenous territories, and our support contributed to improving policy orientation and national regulation. Due to this work, the Samito and Santa María peasant communities were provided land entitlement. Furthermore, we are part of the Advisory Committee of the Rural Land Cadastre, Titling and Registration Project in Peru.

We provided advice to several land demarcation and entitlement processes for native communities, and supported the delimitation and entitlement of land of peasant communities. We offered training to Indigenous Peoples with regard to land management from a sustained approach of their rights.

In October we published “Una Primera Mirada: Situación Legal de la Tenencia de Tierra Rurales en el Perú” (Legal Tenure of Indigenous Peoples Lands), a document that analyzes different reforms regarding land entitlement in our country and identifies the problem surrounding governance, institutionalism and procedures established for the access to rural property, in addition to proposing improvements for the access to private and collective rural property. This publication features an audiobook version in Spanish and Quechua.

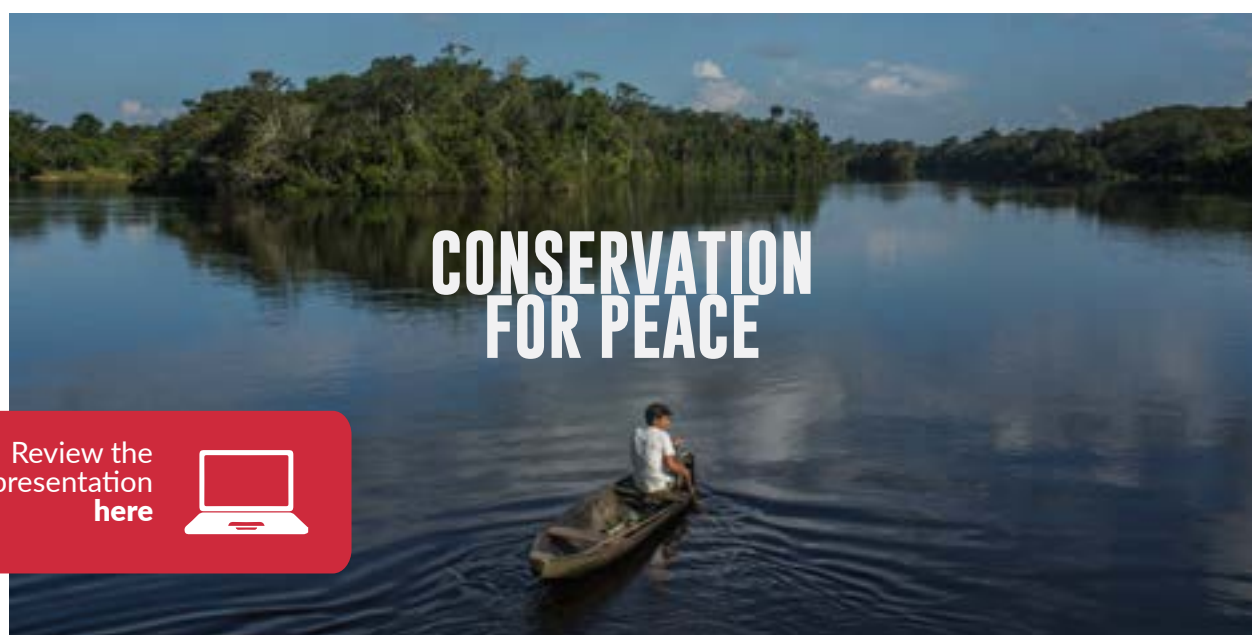
## CONSERVATION FOR PEACE

The Conservation for Peace project was implemented in September 2014 until December 2016, in the influence zone of the Alto Nanay Pintuyacu Chambira Regional Conservation Area and the Allpahuayo Mishana National Reserve buffer zone. We worked with communities of Samito, Santa María, Diamante Azul, San Juan de Ungurahual and Pucaurco, all of them located in the District of Alto Nanay, Province of Maynas (Loreto).

The project focuses on working on social conflicts from a communal level. In all, a total of twenty-four conflicts related to the use of and access to natural resources linked to issues such as communal land use, logging, territorial limits, lack of access to information, absence of an alert system and natural resources management were addressed.

For the management and transformation of conflicts, we provided training for twenty-three local leaders of five communities, recognized as Agents of Peace. Additionally, with the support of regional authorities, we implemented an Early Warning System in Loreto, intended to identify conflicts linked to the use of natural resources, and the Regional Office for Dialogue and Conflict Management in this region.

Through the song “Mejor es Dialogar”, interpreted by the legendary Cumbia band Los Wemblers, the project's message was expanded to social networks and local media in Loreto. Experiences were identified through different audiovisual products such as two multimedia reports, a documentary and photographic display.







## IT IS BETTER TO DIALOGUE

Through the song "Mejor es Dialogar", interpreted by the legendary Loreto Cumbia Amazon band Los Wemblers, the projects message in a simple manner reached groups targeted in the project. The song was broadcast by top radio stations in the region.





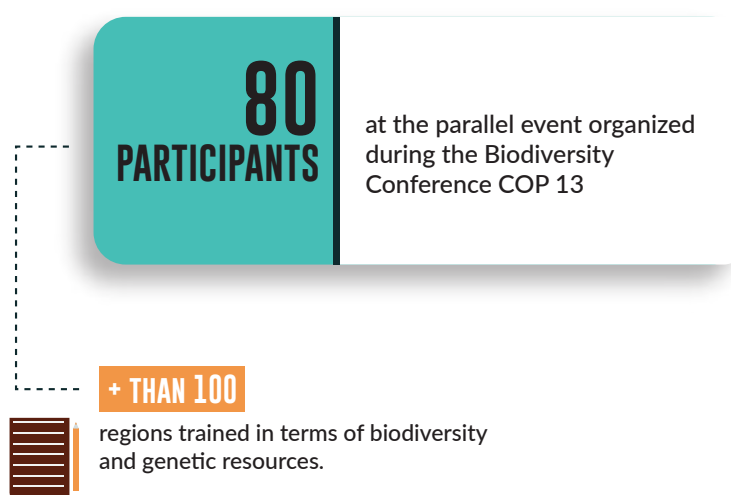
## AGROBIODIVERSITY AND TRADITIONAL KNOWLEDGE

We continued with our work contributing to research and dissemination with regards to genetic resources. Along these lines, we organized the parallel event “Genetic Resources as Natural Information, during the thirteenth meeting of the Conference of Parties (COP) to the United Nations Convention on Biological Diversity, that took place in Mexico.

Another important accomplishment was the adoption, after more than seven years, of the regulation that creates and recognizes agrobiodiversity zones. We worked the original draft together with social institutions such as INIA and IDMA. As a result, at least five sites rich in agrobiodiversity were immediately benefited at the possibility of being

recognized as an agrobiodiversity zone (e.g. Pariahuanca, Laria, Lares, Sapuena and Flor de Castaña, among others).

Finally, we completed training and awareness workshops in four cities (Iquitos, Tarapoto, Arequipa, Piura) on access to genetic resources and intellectual property, as part of the GIZ ProAmbiente Program.



## IMPROVED MANAGEMENT OF FORESTS, WILDLIFE AND OCEANS

Our work focused on providing support to strengthen the tools and institutions in charge of forest management. SPDA also began work contributing to the fight against illegal wildlife trade. We promoted the establishment of a Reserved Zone Mar Pacífico Tropical and improved the normative framework for artisanal fishing and the control of illegal fishing activities.

### FOREST INSTITUTIONALITY

After supporting the approval of four regulations of the Forestry and Wildlife Law in 2015, we provided advice to the State, mainly to the National Forest and Wildlife Service (SERFOR), on the elaboration of complementary norms, to adequately implement the regulations. The issues covered were related to the custodians of forest patrimony, concessions in the use of agroforestry, deforestation and land use change, sanctioning procedures, among others.

A significant achievement was the election of representatives of civil society organizations before the SERFOR Directive Council. SPDA and Proética facilitated this participative process.

### ENVIRONMENTAL IMPACTS IN THE FORESTRY SECTOR

We participated in the process to elaborate the National Plan for Oil Palm, emphasizing the need to clarify the environmental and agricultural legal frameworks, mainly on issues related to the environmental certification of agricultural investments in Amazon

territories, as well as strengthen the regime to access agricultural land in the Amazon. All these observations were formally presented to the Ministry of Agriculture and Irrigation and discussed in different regional workshops.

### REDD+ IN PERU

SPDA supported the Ministry of Environment in the elaboration and approval of a draft Regulation of the Law of Retribution of Ecosystem Services, published in July 2016.

Additionally, we worked on the elaboration of guideline proposals and complementary norms in terms of ecosystem services linked to the forestry sector, such as the REDD+ register and norms on forest cover monitoring.

Like previous years, we implemented a survey to systematize and monitor investments in Peru on REDD+ through the support of the REDDX Tracking Expenditures platform.

## **FIGHT AGAINST THE ILLEGAL TRADE OF WILDLIFE**

In 2016, SPDA initiated actions related to the illegal trade of wildlife, mainly on the Peru – Ecuador border, from a public policy perspective and legislation. We conducted a legal analysis of the issue, including analysis of national and foreign legislation.

In alliance with the Wildlife Conservation Society (WCS), we coordinated joint efforts between SERFOR, the Public Ministry and forest authorities in Tumbes, Piura and Lambayeque, the Ministry of Foreign Affairs and Ecuadorian authorities, to address problems of the transboundary illegal trade of wildlife in both countries.

SPDA contributed by placing the issue on the policy agenda, disseminating the problem through *Actualidad Ambiental* and participating in workshops in Tumbes, Piura, Lima and Iquitos.

## **INTEGRATED MANAGEMENT OF THE SEA IN PERU**

In 2016, SPDA began research and analysis work focused on the support of legal and policy reform processes, necessary for the responsible management of fisheries and marine conservation in Peru. The establishment of alliances and coordinated work with institutions of civil society, experts and authorities has been a key task for this first stage. Additionally, we worked to disseminate the importance of conserving the Tropical Pacific Sea of Peru on the coast of Piura and Tumbes

## THE PROTECTION AND DEFENSE OF ENVIRONMENTAL RIGHTS

Environmental rights and access to environmental justice ensure the protection and defense of other fundamental rights such as rights to a healthy and balanced environment, the collective rights of indigenous peoples, the right to public health, among others. In this regard, during 2016, we continued to work in favor of the active exercise of these rights, through Legal Clinics and the Alerta Ambiental platform

### ACCESS TO ENVIRONMENTAL JUSTICE

Through the Legal Clinics in Madre de Dios and Loreto, we continued to receive and attend several consultations linked to issues such as the use of natural resources, land management, illegal activities, among others.

We organized six training workshops with SPDAs Free Legal Clinic in Madre de Dios on issues of access to environmental justice, targeted to forest users: forest concessionaries, members of native communities, holders or owners of agricultural land and members of the Tambopata National Reserve Management Committee.

In the case of Loreto, we undertook coordinated work with Public Prosecutors specialized in Environmental Matters

and the Police, for the execution of raids related to wildlife illegal trade, the management of wildlife in captivity, among others. Additionally, SPDA participated in several training workshops both for public officials and for the public at large, in terms of the conservation of natural resources and environmental protection, offering expert opinions to the regional press on issues such as air contamination, among others.

## THE ENVIRONMENTAL ALERT PLATFORM

In its fourth year, Environmental Alert has become a key issue for SPDAs work on environmental justice. This tool, that helps to monitor citizens' environmental complaints, has focused on claims made by forest users affected by illegal activities in Madre de Dios.

In 2016 SPDA introduced a process to expand the scope of Alerta Ambiental to new zones in Madre de Dios, for example, the sector where chestnut activities take place. Furthermore, in 2017 we initiated an interesting process to evaluate the implementation of Alerta Ambiental in Piura, allowing the platform to act in a different ecosystem: the marine coastal zones.

## INFORMATION ON ENVIRONMENTAL RIGHTS

In 2016, SPDA continued to inform citizens of their environmental rights, seeking to contribute to their effective application. First, we participated as a focal point for the Peruvian civil society and provided technical support to the Ministry of Environment during the negotiation process for the adoption of a regional instrument that would allow the effective implementation of Principle 10 of the Rio Declaration on Environment and Development on access rights. We also worked collaboratively with several organizations in the region in the collation denominated "The Access Initiative".

Related to this matter, we launched three publications, including an analysis of cases on environmental impact assessment processes in six Latin American countries. These publications together with the six launched in 2015 were granted the National Environmental Award presented by the Ministry of Environment.

The multimedia specials were: Mar Pacífico Tropical Peruano, synthesizing the importance of conserving the sea in Piura and Tumbes, and our impressive photographs on biodiversity in the zone; Minería y Fiebre de Oro in Madre de Dios, containing stunning images and statistics on deforestation in the Amazon; Conflicto en la Quebrada, a report that narrates the existing conflict

between two communities in Loreto; Agents of Peace, that recounts the history of how five communities of Alto Nanay learned to manage their conflicts.

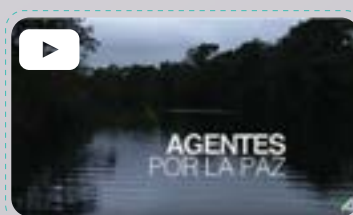

## CAMPAIGNS

In 2016, SPDA undertook two campaigns and a Hackathon that allowed us to reach different audiences with concrete messages.

### #SOMOSTAMBOPATA

The campaign #Somos Tambopata proposes a positive change when facing the challenge presented by illegal mining: we must work together on finding a solution to the advancement of illegal mining.

To this effect, actors, musicians and singers were convened to interpret the song "The future is green", a theme that intends to transmit the mix of anger and hope. Anger for what is happening at the important National Reserve, and hope due to the existence of people and institutions that are committed to defend Tambopata, through proper conservation.

This campaign also emphasized the history of people who are committed to the sustainable development of Tambopata National Reserve and disseminated through social networks, data to inform and raise awareness among citizens.

### RESPONSIBLE CONSUMPTION

In alliance with B-Green and Food Bank of Peru, SPDA organized a campaign on the responsible consumption of food, in order to sensitize Peruvians on the impacts from food wastage in our environment and society.

Thanks to the support of the Municipality of San Isidro, an event "Think.Eat.Save" took place at Parque Caceres, where renowned chefs such as Palmiro Ocampo, Diego Muñoz and Wilfred Dass met and prepared dishes with food that is often discarded.

During the event, discussions were took place on food security and food wastage, and gastronomic demonstrations were conducted.

In addition, SPDA participated in a new edition of Pecha Kucha Night Verde that addressed the issue of responsible consumption, with the presence of hundreds of people.

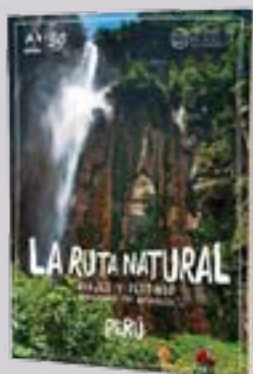
